Below you will find information on happenings at Casco Bay Lines.

Pier Work - Peaks Island

The contractor for Maine Department of Transportation continues to work on the car ferry fender system at Peaks Island. This work requires suspension of car ferry trips for short windows of time based on tide and weather. When car ferry trips are suspended, Lionel Plante Associates will be providing alternate car ferry service on its vessel. When LPA is providing service they will leave from Casco Bay Lines in Portland and from their facility on Peaks Island. The following trips will be operated by LPA:

Thursday, May 31st - 4:30 and 5:35 PM

Monday, June 4th - 9:15, 10:15 and 11:15 AM

Tuesday, June 5th - 10:15 AM, 11:15 AM and 12:15 PM

Wednesday, June 6th - 10:15 AM, 11:15 AM and 12:15 PM

Thursday, June 7th - 11:15 AM and 12:15 PM
