Dear CBL Finance Committee,

Thanks for this opportunity to provide comments on the contemplated changes to commercial rates on the Peaks Ferry.

A few ideas:

If a vehicle does not fit inside of the painted lanes on the boat, it will not be transported. Trucks that overlap lanes effectively block two lanes at once, really reducing the opportunity to board for passenger vehicles and other trucks that stay within the lanes. There is commercial barge service available for these vehicles.

If this is not possible:

Charge by the foot (including overhang of lumber, bike racks, trailers) for all vehicles. If you continue to allow trucks that occupy two lanes, charge 2 x the rate.

Or:

Of the 16 or so sailings a day (W-Sun) have designated priority boarding. Sonme sailings would be CFO (commercial freight only - trucks, vans, cars with trailers, campers) and PCO (passenger cars under 20' only). On CFO runs, allow cars on a space available basis) This way islanders could more easily predict which sailings would have the maximum number of spaces available, no one would turn the corner on Welch Street to see a logging truck in front of them!

Large Vehicle Fare Proposal

On behalf of the islanders I've spoken to, I support the proposal outlined in both the 11/19 and 11/12 meetings, with one exception as detailed below.

I propose reducing the "Off Peak" passholder fare from \$82.65 to \$46.00. This adjustment is based on the excess vehicle capacity during the non-summer season and the feedback from PI islanders that this scheme unfairly burdens residents and passholders who <u>need</u> to travel, particularly on Thursdays and Saturdays. These trips are mainly for healthcare, caring for aging parents or caretakers, and employment-related reasons. However, capacity is not a significant challenge during the winter season. The FINCOM and Board chairs have repeatedly stated that the vehicle tariff, in addition to the passholder premium, is not a substantial contributor to the deficit reduction goal. While spreading "demand" (eliminating "wacky Wednesday") is an important issue during the summer, it is relatively minor issue during the winter season.

Hi Tom,

I'm reaching out to make sure are aware of further changes being discussed at CBL for large vehicles which may impact Maine Island Kayak as an island small business. The new rates will affect large vehicles, currently known as commercial rates.

The goal is to make rates more fair, charging by size taken up on the boat, and increase revenues, while supporting island and small businesses with opportunity to get the passholder discount rate with an annual pass for a standard sized 20' or below, truck.

Big changes are:

- -commercial plate doesn't matter, standard American pick up with commercial plates same rate as same size truck with regular plates
- -charges based on size (length) not weight, truck can be filled with granite rocks or pipes or pillows, no charge
- -size measured from front to rear, including anything that sticks out (bike rack, lumber, kayak) plus trailers etc.
- -standard size 20' truck eligible for passholder discount rate if passholder in the truck
- -larger vehicle, whether a box truck or truck with trailer or Suburban/truck with bike/kayak rack longer than 20' in total, not eligible for passholder discount
- -size matters, so flatbeds, etc will pay a lot more, weight doesn't matter

Rates for standard size truck remain as per last summer, if you have an annual pass or a 90 day pass with vehicle add on it's \$46 off peak all days, \$46 summer/peak Sun-Wed and \$83 summer Thurs-Sat.

Hi Jean,

Sorry for the delay. I wanted to run this by Chuck before I responded.

Basically, Chuck thinks this proposal is good. Here are his comments:

- 1. Length vs. weight--YES! PLEASE! Length is more applicable to the car ferry than weight.
- 2. The 20-foot limit is good because most regular pickup trucks are under that length.
- 3. Chuck says that most contractors who go out daily for weeks or even a month or two at a time use regular pickup trucks, which would be under the 20 foot limit. (building an addition, or a long term electrical job). So they would buy 90 day passes and the cost to island homeowners would not be any more than it is currently
- 4. Something to consider: It is the case that there are some types of contractors need to bring trucks that will not fit under the 20 foot limit--flooring installers, plumbers, etc. These people would probably need to go out for a few days in a row....so adding \$212 + per day (from April-Oct) might mean a more significant cost to island homeowners having that work done. It would be great to figure some way to reduce that cost to island homeowners.

4a. Maybe, down the line, there could be a way islanders homeowners/renters could get a certain # of contractor passes/year (just a few--like 2 or 3) to allow larger contractors to travel for the pass-holder rate? The criteria for getting those passes could be that the homeowner/renter is eligible for, or maybe has, a residential pass.

That is Chuck's feedback for now. Thank you for asking him. I start school at 7:40AM every day so logging onto the meetings is not usually possible. And Chuck is working up in Richmond right now so attending would be hard for him. But either one of us is happy to speak by phone if you have questions after the meeting. Chuck--(207) 232-7499 and me (207) 233-6985.

One other thing--to help islanders who need work done on their homes--it would be great if CBL could advertise or somehow get the word out to island residents and contractors who come in to buy tickets, that, if their vehicle is 20 feet or under, they can buy a 90 day pass and receive lower vehicle rates. I know it will be on the CBL site, but some outreach beyond that might help.

The reason I suggest that: I know it is hard to have all employees on the same page, and that many of the ticket sellers are just teens (some my own students!), but when I was deciding whether to buy an annual pass or a 90 day pass this past June, I asked the guy working the ticket counter if I would get the vehicle discount on a 90 day pass and he said he didn't know. I decided to get the annual pass anyway (Carol was with me and urged that), but I probably did not need the annual....no big deal, and again, believe me I know how hard it is to train teens! But I would feel bad if someone on a fixed income made that same mistake..

Thanks again. I hope the meeting goes well tomorrow.

Thanks for passing this along. Our van is 16' 8" so we are well below the 20 plus rates.

I read the attachment you sent the plan looks like a good financial incentive to be fair to islanders.

I had a couple thoughts on the space taken up by over 20' vehicles. (I am sure you are painfully aware of these thoughts).

It doesn't address being bumped by a large vehicle and increasing the car waiting times and the pedestrians congestion that pushes cars backed up on the both sides. On the Peaks side, the lines back up on Island Ave create an unsafe corner for both pedestrians and vehicles.

On the Portland side I've seen cars backed up to the entrance of the parking garage making it hard for any car to turn from Commercial St. The management of the cars on the Portland side is at least managed by crew and CBL staff. The Peaks side feels like a free for all, chaotic mosh pit with no management except for the crew that are loading cars.
